The parties hereto, by and through their undersigned counsel, herewith stipulate for an extension of deadlines associated with Defendant Nautilus Insurance Company's ("Nautilus's") Notice of Motion and Motion to Strike Allegations in Plaintiffs' Second Amended Complaint and Defendant Nautilus's Motion to Dismiss Plaintiffs Robert "Sonny" Wood and Access Medical, LLC's Second Amended Complaint (collectively "Motions"), which were both filed on October 25, 2018. This is the first stipulation for extension of time. The date that Mr. Wood and Access Medical, LLC's Oppositions to the Motions ("Oppositions") are due is currently November 8, 2018.
