WHEREAS, Federal District Courts have "wide discretion in controlling discovery." *Little v. City of Seattle*, 863 F.2d 681, 685 (9th Cir. 1988).

WHEREAS, to determine if a stay is appropriate, the court considers (1) damage from the
stay; (2) hardship or inequity that befalls one party more than the other; and (3) the orderly
course of justice. *See Dependable Highway Exp., Inc. v. Navigators Ins. Co.*, 498 F.3d 1059,
1066 (9th Cir. 2007) (setting forth factors). Here, the factors support a stay of all proceedings
based on the pending Motion to Dismiss.

WHEREAS, the parties believe a stay is warranted because they will be able to avoid the cost of expense of continued written discovery and depositions on issues that may be unnecessary based on the outcome of the pending Motion to Dismiss. Moreover, the Court will be relieved of expending further time and effort considering any discovery-related motions or protective orders.

WHEREAS, the parties agree there will be no significant hardship or inequity against any party, and it is appropriate for this Court to exercise its power to grant a stay of discovery at this time. A trial date has not yet been set and the outcome of the pending Motion to Dismiss may potentially result in resolution of the entire case.
