Plaintiff U.S. Equal Employment Opportunity Commission (the "EEOC" or "Commission") and Defendants Lucinda Management, LLC, Centennial Food Corporation dba IHOP Restaurant, Nellis Food Corporation dba IHOP Restaurant, Cheyenne Food Corporation dba IHOP Restaurant, Craig Food Corporation dba IHOP Restaurant, Bayshore Food Corporation dba IHOP Restaurant, DiHOP Corporation dba IHOP Restaurant, and Cooper Street Clam & Oyster Bar, LLC ("Defendants")(collectively, the "Parties") hereby jointly stipulate to modify the deadline in Sections VIII.A.2 of the Consent Decree in the abovecaptioned case from April 11, 2019 to April 19, 2019.

10 Pursuant to Section VI.A of the Consent Decree, signed by this Court on February 19, 11 2019, terms of the Consent Decree may be amended or modified if made in writing, signed by 12 an authorized representative of the Parties, and approved by the Court. Therefore, the Parties agree that additional time is required for Defendants to comply with Section VIII.A.2 of the Consent Decree.
