22 Plaintiff Deutsche Bank National Trust Company, as Trustee for Holders of the GSAA
 23 Home Equity Trust 2006-11 Asset-Backed Certificates Series 2006-11 (**Deutsche Bank**), and
 24 SFR Investments Pool 1, LLC (**SFR**) respectfully submit the following stipulation to allow
 25 Deutsche Bank additional time to oppose SFR's motion to dismiss (Doc. No. 18).

26 SFR filed its motion on November 20, 2017 (Doc. No. 18). Deutsche Bank's deadline to
 27 file its opposition is December 4, 2017. Deutsche Bank and SFR stipulate to extending Deutsche
