1 Pursuant to Local Civil Rule 6-1(a), Defendant Del Taco Restaurants, Inc.
2 (“Defendant”) and Plaintiff Michael Jaffey (“Plaintiff”) (collectively, the “Parties”) by and
3 through their undersigned counsel, hereby stipulate and agree as follows:

4 WHEREAS, Plaintiff initiated this action by filing a complaint on October 5, 2017;

5 WHEREAS, Plaintiff served Defendant with the summons and complaint on October
6 11, 2017;

7 WHEREAS, pursuant to Rule 81(c) of the Federal Rules of Civil Procedure,
8 Defendant’s current deadline to respond to the complaint is November 1, 2017;

9 WHEREAS, the Parties have agreed to a 21-day extension of time for Defendant to
10 respond to Plaintiff’s Complaint;

11 WHEREAS, this stipulation and request is being entered into in good faith, and not for
12 reason of delay, in order for the parties to consider and confer regarding Defendant’s intention
13 to compel arbitration of Plaintiff’s claims on an individual basis;

14 WHEREAS, this is the first stipulation for an extension of time to respond to Plaintiff’s
15 Complaint in this action;

16 WHEREAS, by entering into this Stipulation, the parties agree that Defendant has not
17 waived its right to bring any motion in response to Plaintiff’s claims, and have specifically not
18 waived their right to compel individual arbitration of Plaintiff’s claims;

19 NOW, THEREFORE, the Parties, by their undersigned counsel, hereby stipulate to
20 extend by 21 days, Defendant’s deadline to file its response to Plaintiff’s Complaint. Defendant
21 shall have up to and including, November 22, 2017, to file a response to Plaintiff’s Complaint.
