**STIPULATION AND ORDER TO
EXTEND BRIEFING SCHEDULE ON
MOTIONS FOR SUMMARY JUDGMENT**

(SECOND REQUEST)

21 Plaintiffs Nationstar Mortgage LLC and Federal Home Loan Mortgage Corporation
22 (**plaintiffs**) and defendant Travertine Lane Trust (**Travertine Lane**), agreed to (1) an extension of
23 time for plaintiffs to file an opposition to Travertine Lane's motion for summary judgment, filed June
24 6, 2018 as Doc. No. 25.

25 Plaintiffs' opposition to Travertine Lane's motion for summary judgment is due June 27, 2018.
26 The parties are in agreement that plaintiffs shall have until June 29, 2018 to file their opposition to
27 Travertine Lane's motion for summary judgment, which is the same day as plaintiffs' deadline to file
28 a reply in support of their motion for summary judgment filed on May 7, 2018 as Doc No. 22.

1 Travertine Lane shall have until July 13, 2018 to file its reply in support of its motion for summary
2 judgment.

3 This is the parties’ second request for an extension of this deadline and is not meant for
4 purposes of undue delay but merely to coordinate and streamline briefing schedules.
