Pending before the Court is Defendants’ motion to extend the deadlines in the scheduling order by 120 days. Docket No. 13. Plaintiff filed a response in opposition, and Defendants filed a reply. Docket Nos. 15, 17. The motion is properly decided without a hearing. *See* Local Rule 78-1. Although the circumstances leave much to be desired, good cause exists for a 60-day extension to the deadlines that had not expired prior to the filing of the motion.¹ Accordingly, the motion is **GRANTED** in part and **DENIED** in part, and deadlines are **SET** as follows:

- Initial Experts: April 23, 2018;
- Interim status report: April 23, 2018;
- Rebuttal experts: May 23, 2018;
- Discovery cutoff: June 22, 2018;

¹ The deadline to amend the pleadings expired a month before the motion was filed and, therefore, the request to reopen that deadline must be supported by both good cause and excusable neglect. *See, e.g.,* Local Rule 26-4; Fed. R. Civ. P. 6(b)(1)(B). Insufficient justification exists to reopen that deadline.

- Dispositive motions: July 23, 2018;
- Joint proposed pretrial order: August 22, 2018, or 30 days after dispositive motions are resolved.²
