- 2. The Scheduling Order also directed the parties to meet and confer as required by Fed. R. Civ. P. 26(f) not later than May 21, 2018. *See id*.
- 3. The parties conferred pursuant to Rule 26(f) on May 17, 2018, and have submitted a Rule 26(f) Report and Proposed Discovery Plan (the "Rule 26(f) Report"). *See* ECF No. 60.
- 4. To provide the parties sufficient time to conduct discovery and avoid scheduling conflicts with other matters, both parties hereby jointly request the Court to modify certain of the deadlines in the Scheduling Order as set forth in the Rule 26(f) Report to allow adequate time for discovery in this action. Specifically, the parties jointly request that the discovery cutoff, dispositive motion deadline, and date for filing the joint pretrial order each be extended by approximately five weeks.
- 5. This is the first request for extension of these deadlines. No discovery has been completed in this action to date, beyond the disclosures provided in the parties' briefings on the pending motion for preliminary injunction.
- 6. Good cause exists for this request. The parties seek a short five week extension of the discovery, dispositive motion, and pretrial order deadlines in the Scheduling Order. Modifying theses deadlines will permit the parties to take discovery in this action and prepare their respective cases, and avoid scheduling conflicts with other matters. No party will be prejudiced by the extension requested.
- 7. For these reasons, the parties respectfully request that the Court grant this Joint Motion and extend the deadlines in the Scheduling Order as follows:
