9 After a hearing on January 12, 2018, I granted the petition and unsealed more than 300  
10 pages of federal search warrants related to Stephen A. Paddock and the October 1, 2017,  
11 shooting at the Route 91 Harvest Festival.<sup>1</sup> I kept one exhibit sealed, however—a state court  
12 warrant, which Eighth Judicial District Court Judge Elissa Cadish was scheduled to consider  
13 unsealing just days later. After Judge Cadish unsealed the state-court warrants, I ordered the  
14 government to show cause why I shouldn't unseal that final exhibit.<sup>2</sup> The government timely  
15 responded by filing an unsealed copy of that warrant<sup>3</sup> and moving to unseal all the federal cases  
16 containing the search warrants related to Paddock.<sup>4</sup> The media petitioners join in that motion.<sup>5</sup>

17 Good cause appearing, IT IS HEREBY ORDERED that **the government's obligations**  
18 **under the show-cause order [ECF No. 12] are deemed satisfied and discharged;**

19 IT IS FURTHER ORDERED that **the government's motion to unseal [ECF No. 14, 16]**  
20 **is GRANTED.** The Clerk of Court is directed to **UNSEAL the following cases**, redacting from  
21 the documents filed in those cases only personal-data identifiers as Local Rule IC 6-1 requires:
