22 2. On December 21, 2017, the Court entered an Order requiring the parties to either

24 3. On January 19, 2018, the parties entered into a Stipulation to Extend the Deadline
 25 to File Dismissal or Submit a Joint Status Report extending the deadline to February 2, 2018.
