**STIPULATION AND ORDER TO
 ARBITRATE AND STAY PROCEEDINGS**

 18 This stipulation is entered into by the Parties, Nicole Lease (“Plaintiff”) and Employment
 19 Services, Inc., d/b/a Aviation Institute of Maintenance (“Defendant”), by and through their counsel,
 20 with reference to the following:

21 WHEREAS, during the course of her study with Defendant, Plaintiff allegedly entered into
 22 an agreement with Defendant to arbitrate disputes arising out of or relating to Plaintiff’s enrollment
 23 and study with Defendant, hereinafter referred to as the “Arbitration Agreement”;

24 WHEREAS, on August 22, 2017, Plaintiff filed a Complaint in the Eighth judicial District
 25 Court, Clark County, Nevada, which Defendant removed to this Court pursuant 28 U.S.C. § 1331,
 26 styled as *Nicole Lease v. The Aviation Institute of Maintenance*, Case No. 2:17-cv-02835-RFB-

1 NJK, alleging various claims of violation of Nevada and possibly federal law.

2 WHEREAS, the claims alleged in the Action fall within the scope of the Arbitration
3 Agreement;

4 IT IS HEREBY STIPULATED by and between the Parties as follows:

5 1. This Action, in its entirety, shall be submitted to binding arbitration with JAMS
6 before retired judge Philip Pro or Lawrence Leavitt, pursuant to a Stipulated Arbitration Agreement
7 executed by the Parties;

8 2. All proceedings in this Action shall be stayed and this Court shall retain jurisdiction
9 over this Action pending the conclusion of the arbitration.
