20 respective counsel of record, hereby stipulate and agree as follows:

21 WHEREAS, on April 8, 2019, Nationstar and Freddie Mac filed a Motion for
22 Reconsideration of Order Granting in Part and Denying in Part GR Investments LLC’s and
23 Silverstone LLC’s Motion to Dismiss Complaint. ECF No. 41.

24 WHEREAS, on May 1, 2019, Defendants filed their Response to Motion for
25 Reconsideration and Counter-Motion for Reconsideration. ECF Nos. 43 and 44, respectively.


