 20 Discover Financial Services' ("Discover") response to Plaintiff's First Amended
 21 Complaint (ECF No. 7) is due April 18, 2018. Plaintiff Lisa R. Salgado and Discover
 22 agree that Discover has up to and including May 2, 2018 to respond to Plaintiff's
 23 pleading to provide time for the parties to continue investigating Plaintiff's
 24 allegations and discuss the potential for an early resolution of the claims asserted
 25 against Discover. While this is the parties' fourth request for an extension, counsel
 26 for the parties are actively conferring about this case and informally exchanging
 27 documents to evaluate their respective positions. Moreover, Discover currently is the
 28 only defendant involved in the case. *See* ECF No. 14 (dismissing Equifax as a party).

1 Thus, the requested extension will not affect other parties and may avoid
2 unnecessary litigation and expense. Finally, the parties' previous requests for
3 extension have each been modest.¹

4 This is the fourth request for such an extension, and it is made in good faith
5 and not for purposes of delay.


