15 In accordance with LR IA 6-1, LR 7-1(a), and 7-2, the parties stipulate as
 16 follows:

17 1. On February 22, 2018, Rocky Mountain Hospital and Medical Service,
 18 Inc. doing business as Anthem Blue Cross and Blue Shield, erroneously named as
 19 Blue Cross of Colorado, filed Defendant's Notice of Motion and Motion to Dismiss
 20 Plaintiff's Complaint Pursuant to F.R.C.P. Rule 12(b)(6) (ECF No. 12). In
 21 accordance with LR 7-2(b), the plaintiff, Las Vegas Regional Surgery Center, L.P.,
 22 has up to and including March 8, 2018, to file a response to the motion.

23 2. Counsel for Las Vegas Regional Surgery Center serves on the board of
 24 directors of a local non-profit organization. The non-profit's large annual event
 25 occurred on March 2 through March 4. Counsel was in charge of running the event,
 26 which involved a substantial amount of time before, during, and after the event.

1 3. Hence, Las Vegas Regional Surgery Center's counsel asked for and
2 Blue Cross's counsel agreed to grant the Las Vegas Regional Surgery Center an
3 extension of time until March 19, 2018, to file its response to the motion to dismiss.

4 4. Accordingly, the parties stipulate that Las Vegas Regional Surgery
5 Center shall have up to and including March 19, 2018, to file a response to the
6 motion. In accordance with LR 7-2, Blue Cross may file a reply in support of the
7 motion on or before March 26, 2018.

8 5. This is the first request for an extension of time to file an opposition to
9 the motion to dismiss.
