**JOINT STIPULATION AND ORDER
 EXTENDING DEFENDANT TRANS
 UNION LLC’S TIME TO FILE AN
 ANSWER OR OTHERWISE RESPOND
 TO PLAINTIFF’S COMPLAINT (FIRST
 REQUEST)**

15 Plaintiff Delores Crutcher (“Plaintiff”) and Defendant Trans Union LLC (“Trans
 16 Union”), by and through their respective counsel, file this Joint Stipulation Extending Defendant
 17 Trans Union’s Time to File an Answer or Otherwise Respond to Plaintiff’s Complaint.

18 On February 18, 2018, Plaintiff filed her Complaint. The current deadline for Trans
 19 Union to answer or otherwise respond to Plaintiff’s Complaint is March 16, 2018. The
 20 allegations in Plaintiff’s Complaint date back to May 2017 and relate to one account allegedly
 21 omitted from the Plaintiff’s credit file. Trans Union needs additional time to locate and assemble
 22 the documents relating to Plaintiff’s credit file and any disputes submitted by Plaintiff. In
 23 addition, Trans Union’s counsel needs additional time to review Trans Union’s documents and
 24 respond to the allegations in the Complaint.

1 Plaintiff has agreed to extend the deadline in which Trans Union has to answer or
2 otherwise respond to Plaintiff's Complaint up to and including April 16, 2018. This is the first
3 stipulation for extension of time for Trans Union to respond to Plaintiff's Complaint.
