**STIPULATION AND [PROPOSED]
 ORDER TO EXTEND DEADLINE FOR
 DEFENDANT PHWL, LLC TO
 RESPOND TO AMENDED
 COMPLAINT FOR DECLARATORY
 JUDGMENT**

(Second Request)

 20 Pursuant to LR IA 6-1, LR IA 6-2, and LR 7-1, Defendant PHWL, LLC ("PHWL")
 21 and Plaintiff Aladdin's Eatery Systems, Inc ("Plaintiff"), by and through their respective counsel,
 22 hereby stipulate and agree to extend the deadline for Defendant PHWL to plead or otherwise
 23 respond to Plaintiff's Amended Complaint for Declaratory Judgment (Doc. #31) ("Amended
 24 Complaint") until June 10, 2019, and request that the Court enter an Order approving the same.

25 On March 22, 2019, the Court entered an Order (Doc. #30) granting PHWL's Motion to
 26 Dismiss Plaintiff's Complaint Pursuant to Fed. R. Civ. P. 12(b)(1) and 12(b)(6) (Doc. #21), and
 27 providing Plaintiff until April 12, 2019 to file an Amended Complaint.

1 On April 12, 2019, Plaintiff timely filed its Amended Complaint (Doc. #31).

2 On April 24, 2019, the Court entered an Order on the parties' stipulation granting
3 PHWLV an extension of time to respond to the Amended Complaint (Doc. #35).

4 PHWLV has requested an additional extension until June 10, 2019 in which to further
5 analyze Plaintiff's claims, prepare an appropriate response, and to enable the parties to pursue
6 further discussions regarding potential settlement. This is PHWLV's second request for an
7 extension of its deadline to respond to the Amended Complaint. Plaintiff has agreed to the
8 requested extension as a matter of professional courtesy.

9 This Stipulation is entered into in good faith and is not intended to delay these
10 proceedings. The parties will not be prejudiced by this Stipulation and the parties are in
11 agreement with respect to PHWLV's requested extension.
