IT IS HEREBY STIPULATED AND AGREED, by and between the parties, that the time for Plaintiff Universal Entertainment Corporation ("UEC") to file its Response to Defendants' Motion to Compel Communications Between UEC and the City-Yuwa Partners Law Firm ("Motion to Compel," filed under seal on December 21, 2020 – ECF No. 263) is extended for fourteen (14) days, from January 4, 2021 to January 18, 2021. The parties further agree that the time for UEC to respond<sup>1</sup> to the associated Motion to Seal (filed on December 21, 2020 - ECF No. 262) is extended for seven (7) days from December 28, 2020 to January 4, 2021. This is the first stipulation for extension of time for UEC's responses to either the Motion to Compel or Motion to Seal. This extension request is to accommodate counsel's schedules during the Christmas and New Year's Day Holidays, as well as to provide counsel additional time to evaluate and prepare UEC's responses. Accordingly, for good cause showing, the parties have agreed to the foregoing extension. IT IS SO ORDERED.
