18	CARDENAS, P#16013, and MARK PINEDA, P#10128, and send the same to the U.S. Marshal	
19	together with two (2) copies of the Amended Complaint (ECF No. 9), two (2) copies of the Court's	
20	Screening Order (ECF No. 10), and two (2) copies of this Order for service on these Defendants.	
21	IT IS FURTHER ORDERED that the Clerk of Court shall also send to Plaintiff two (2) USM-	
22	285 forms. Plaintiff shall have until March 31, 2020 to complete the USM-285 service forms and	
23	return them to the U.S. Marshal, 333 Las Vegas Blvd. South, Las Vegas, Nevada 89101. The U.S.	
24	Marshal shall serve Oscar Cardenas and Mark Pineda within thirty (30) days of receipt of Plaintiff's	
25	completed USM-285.	
26	IT IS FURTHER ORDERED that Plaintiff's failure to timely follow this Order will result in	
27	an Order precluding service on these two potential defendants.
