**JOINT STIPULATION AND ORDER
 EXTENDING DEFENDANT TRANS
 UNION LLC’S TIME TO FILE AN
 ANSWER OR OTHERWISE RESPOND
 TO PLAINTIFF’S COMPLAINT (FIRST
 REQUEST)**

17 Plaintiff Anthony A. Guerrero (“Plaintiff”) and Defendant Trans Union LLC (“Trans
 18 Union”), by and through their respective counsel, file this Joint Stipulation Extending Defendant
 19 Trans Union’s Time to File an Answer or Otherwise Respond to Plaintiff’s Complaint.

20 On April 12, 2018, Plaintiff filed his Complaint. The current deadline for Trans Union to
 21 answer or otherwise respond to Plaintiff’s Complaint is May 4, 2018. Trans Union needs
 22 additional time to locate and assemble the documents relating to Plaintiff’s credit file and any
 23 disputes submitted by Plaintiff. Then, Trans Union’s counsel will need additional time to review
 24 Trans Union’s documents and respond to the allegations in the Complaint.

25 Plaintiff has agreed to extend the deadline in which Trans Union has to answer or
 26 otherwise respond to Plaintiff’s Complaint up to and including June 4, 2018. This is the first
 27 stipulation for extension of time for Trans Union to respond to Plaintiff’s Complaint. The time
 28 within which Trans Union must respond to the Complaint has not yet expired.

1 WHEREFORE, Defendant Trans Union respectfully requests this Court to enter an Order
2 granting this Joint Stipulation Extending Defendant Trans Union's Time to File an Answer or
3 Otherwise Respond to Plaintiff's Complaint and extend the deadline for Trans Union to file its
4 responsive pleading to Plaintiff's Complaint, up to and including June 4, 2018.
