

16 **ORDER**

18 Local Rule 7-1(c) states that "A stipulation that has been signed by fewer than all the parties
19 or their attorneys will be treated---and must be filed---as a joint motion." This stipulation [ECF No.
20 **15**] is between the plaintiff and only one of the three defendants in this case. Accordingly, I treat it
21 a **joint** motion under LR 7-1(c), find good cause, and **GRANT** it. IT IS THEREFORE ORDERED
22 that the deadline for plaintiff to respond to Trans Union LLC's motion to dismiss [ECF No. 13] is
23 **EXTENDED to July 26, 2018.**
