 19 Union LLC (“Trans Union”), by and through their respective counsel, file this Joint Stipulation
 20 Extending Defendant Trans Union’s Time to File an Answer or Otherwise Respond to Plaintiffs’
 21 Complaint.

22 On April 13, 2018, Plaintiffs filed their Complaint and Trans Union was served on May
 23 17, 2018. The current deadline for Trans Union to answer or otherwise respond to Plaintiffs’
 24 Complaint is June 7, 2018. The allegations in Plaintiffs’ Complaint date back to September
 25 2017. Trans Union is in need of additional time to investigate, locate and assemble documents
 26 relating to Plaintiffs’ claims. In addition, Trans Union’s counsel needs additional time to review
