 26 **STIPULATION AND ORDER TO EXTEND**
CASE MANAGEMENT PLAN DEADLINES
 27 **(Fifth Request)**

1 Pursuant to LR IA 6-1 and LR 26-3, the parties, by and through their respective counsel of
2 record, hereby stipulate and request that the Court reset the following Case Management Plan
3 Deadlines as follows:
4

5 1. On July 30, 2021, the Court issued its Order Granting Stipulation and Order to
6 Extend Case Management Plan Deadlines, which established the Pre-Trial Order Deadline as
7 November 1, 2021. (Dkt. 75).
8

9 2. On September 14, 2021, the Court issued its Order Granting Defendants' Motion
10 to Compel, which (1) required the production of raw testing data to Defendants' expert Dr. Kinsora
11 by September 24, 2021; (2) allowed Dr. Kinsora to and including November 15, 2021 to provide
12 his rebuttal expert report pursuant to FED. R. CIV. P. 26(a)(2)(B); and (3) allowed Plaintiff thirty
13 (30) days after the production of Dr. Kinsora's report to depose him. (Dkt. 79 at 4-5).
14

15 3. Because there is outstanding expert and damages related discovery that will be
16 completed after the November 1, 2021 Pre-Trial Order Deadline, the parties request that the Court
17 extend the Pre-Trial Order Deadline to and including February 1, 2022.
18

19 4. Pursuant to LR IA 6-1(a), the discovery deadline was previously extended on
20 August 20, 2018 (Dkt. 26), January 10, 2019 (Dkt. 41), and July 29, 2019 (Dkt. 45). The parties
21 further note that this case was stayed on October 2, 2019 pursuant to Defendant Forever 21, Inc.'s,
22 bankruptcy petition. (Dkt. 49). On March 24, 2021, the Court issued an Order lifting the
23 bankruptcy stay (Dkt. 67) and the Court entered its Order Resetting Case Management Plan and
24 Other Related Deadlines on April 15, 2021. (Dkt. 71). The Discovery, Dispositive Motion, and
25 Pre-Trial Order Deadlines were subsequently extended on July 30, 2021. (Dkt. 75).
