1 not easily reachable in order to participate in joint case management functions or case-related
2 discussions.²

3 The Plaintiff believes it has sufficient evidence to support the allegations in the
4 Complaint against Kosak. Therefore, Plaintiff believes that this case is appropriate for a
5 summary judgment against Kosak. (Plaintiff acknowledges that a motion was not filed within
6 dispositive motion deadlines.) The Plaintiff is requesting that the Court grant leave to
7 Plaintiff to have 60 days to file a motion for summary judgment.

9 If the Court is not so inclined, Plaintiff will make itself available for settlement
10 conference, or bench trial setting, as the Court wishes.
