ORDER

9 This action began with a pro se civil rights complaint filed pursuant to 42 U.S.C. § 1983
10 by a state prisoner. Plaintiff has submitted an application to proceed in forma pauperis. Docket
11 No. 1. Based on the financial information provided, the Court finds that Plaintiff is unable to
12 prepay the full filing fee in this matter.

13 The Court entered a screening order on June 24, 2019. Docket No. 6. The screening order
14 imposed a 90-day stay and the Court entered a subsequent order in which the parties were assigned
15 to mediation by a court-appointed mediator. Docket Nos. 6, 9. The Office of the Attorney General
16 has now filed a status report indicating that settlement has not been reached and informing the
17 Court of its intent to proceed with this action. Docket No. 14.

18 For the foregoing reasons, **IT IS ORDERED** that:

19 1. Plaintiff's application to proceed in forma pauperis, Docket No. 1, is **GRANTED**.
20 Plaintiff shall not be required to pay an initial installment of the filing fee. In the event that this
21 action is dismissed, the full filing fee must still be paid pursuant to 28 U.S.C. § 1915(b)(2).

22 2. The movant herein is permitted to maintain this action to conclusion without the
23 necessity of prepayment of any additional fees or costs or the giving of security therefor. This
24 order granting leave to proceed in forma pauperis shall not extend to the issuance and/or service
25 of subpoenas at government expense.

26 3. Pursuant to 28 U.S.C. § 1915(b)(2), the Nevada Department of Corrections shall
27 pay to the Clerk of the United States District Court, District of Nevada, 20% of the preceding
28 month's deposits to Plaintiff's account (**Richard W. Peters, #92314**), in the months that the

1 account exceeds \$10.00, until the full \$350.00 filing fee has been paid for this action. The Clerk
2 of the Court shall **SEND** a copy of this order to the Finance Division of the Clerk's Office. The
3 Clerk of the Court shall also **SEND** a copy of this order to the attention of the Chief of Inmate
4 Services for the Nevada Department of Corrections, P.O. Box 7011, Carson City, NV 89702.

5 4. The Clerk of the Court shall electronically **SERVE** a copy of this order and a copy
6 of Plaintiff's complaint, Docket No. 7, on the Office of the Attorney General of the State of Nevada
7 by adding the Attorney General of the State of Nevada to the docket sheet. This does not indicate
8 acceptance of service.

9 5. Service must be perfected no later than January 2, 2020, pursuant to Fed. R. Civ. P.
10 4(m).

11 6. Subject to the findings of the screening order, Docket No. 6, no later than October
12 25, 2019, the Attorney General's Office shall file a notice advising the Court and Plaintiff of: (a)
13 the names of the defendants for whom it accepts service; (b) the names of the defendants for whom
14 it does not accept service, and (c) the names of the defendants for whom it is filing the last-known-
15 address information under seal. As to any of the named defendants for whom the Attorney
16 General's Office cannot accept service, the Office shall file, under seal, but shall not serve the
17 inmate Plaintiff the last known address(es) of those defendant(s) for whom it has such information.
18 If the last known address of the defendant(s) is a post office box, the Attorney General's Office
19 shall attempt to obtain and provide the last known physical address(es).

20 7. If service cannot be accepted for any of the named defendant(s), Plaintiff shall file
21 a motion identifying the unserved defendant(s), requesting issuance of a summons, and specifying
22 a full name and address for the defendant(s). For the defendant(s) as to which the Attorney General
23 has not provided last-known-address information, Plaintiff shall provide the full name and address
24 for the defendant(s).

25 8. If the Attorney General accepts service of process for any named defendant(s), such
26 defendant(s) shall file and serve an answer or other response to the complaint, Docket No. 7, no
27 later than December 3, 2019.



9. Plaintiff shall serve upon defendant(s) or, if an appearance has been entered by counsel, upon their attorney(s), a copy of every pleading, motion or other document submitted for consideration by the Court. Plaintiff shall include with the original document submitted for filing a certificate stating the date that a true and correct copy of the document was mailed or electronically filed to the defendants or counsel for the defendants. If counsel has entered a notice of appearance, Plaintiff shall direct service to the individual attorney named in the notice of appearance, at the physical or electronic address stated therein. The Court may disregard any document received by a district judge or magistrate judge which has not been filed with the Clerk, and any document received by a district judge, magistrate judge, or the Clerk which fails to include a certificate showing proper service.

10. This case is no longer stayed.
