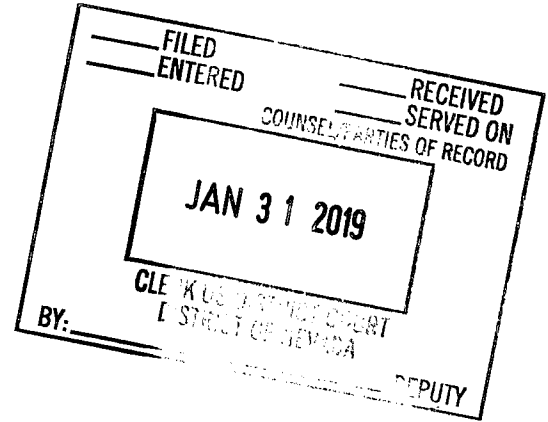

**JOINT STIPULATION AND ORDER

22 Plaintiff Eric Steinmetz ("Plaintiff") and Defendant Trans Union LLC ("Trans Union"), by  
23 and through their respective counsel, file this Joint Stipulation Extending Defendant Trans Union's  
24 Time to File an Answer or Otherwise Respond to Plaintiff's Complaint.

25 On January 10, 2019, Plaintiff filed his Complaint. The current deadline for Trans Union to  
26 answer or otherwise respond to Plaintiff's Complaint is February 1, 2019. Trans Union needs  
27 additional time to locate and assemble the documents relating to Plaintiff's claims and Trans Union's
