17 Plaintiff, Bayview Loan Servicing, LLC (“Bayview”), and Defendant North American
 18 Title Insurance Company (“NATIC”, collectively, the “Parties”), by and through their counsel of
 19 record, hereby stipulate and agree as follows:

- 20 1. On December 2, 2022, Bayview filed a Motion for Partial Summary Judgment [ECF No.
 21 105].
- 22 2. On March 13, 2023, NATIC filed its Opposition to Bayview’s Motion for Partial
 23 Summary Judgment [ECF No. 119] and filed a Countermotion for Partial Summary
 24 Judgment [ECF No. 120].
- 25 3. Bayview’s deadline to file its reply in support of its Motion for Partial Summary
 26 Judgment; and its deadline to respond to NATIC’s Countermotion is May 17, 2023 [ECF
 27 No. 139].

- 1 4. Bayview requests a seven (7) day extension of time to file its reply in support of its Motion
2 for Partial Summary Judgment [ECF No. 105]; and its response to NATIC's
3 Countermotion, making the new deadlines May 24, 2023. The extension is requested to
4 afford Bayview's counsel additional time to review and respond to the arguments in
5 NATIC's Oppositions and Countermotion while counsel is out of state preparing for a
6 trial.
- 7 5. Counsel for NATIC does not oppose the requested extensions.
- 8 6. This is the fourth request for an extension which is made in good faith and not for purposes
9 of delay.
