**STIPULATION AND ~~PROPOSED~~
ORDER TO STAY THE CASE**

Pursuant to Local Rules 6-1 and 26-4, the parties, by and through their respective attorneys of record, stipulate and agree to stay the pendency of this case by forty-five (45) days, to continue the deadline for the parties to file their Joint Pre-Trial order an additional sixty (60) days, and to extend discovery deadlines an additional thirty (30) days.

This is the first request for an extension for the parties to complete the Joint Pre-Trial Order. The Joint Pre-Trial Order is currently due on March 12, 2021. This Stipulation is sought by the parties in order to allow for substantive settlement negotiations to continue with the hopes

1 of resolving this matter. The settlement negotiations are ongoing, and the stay will permit the
 2 parties to continue and exhaust discussions culminating in a settlement agreement or trial.
 3 Currently, the parties have noticed several depositions but the Parties wish to avoid incurring
 4 additional costs and fees in order to accommodate settlement discussions.

5 For this reason, and in order to avoid potentially unnecessary additional fees and costs if
 6 this matter settles, the parties hereby stipulate stay this case forty-five (45) days, or February 19,
 7 2021 and continue the deadline for the parties to submit their Joint Pre-Trial order an additional
 8 sixty (60) days from the date the stay expires, or until April 20, 2021.

9 Accordingly, the parties have agreed and stipulated to the following deadlines:
