 23 IT IS HEREBY STIPULATED AND AGREED, by and between the parties, that the time
 24 for Plaintiff Universal Entertainment Corporation (“UEC”) to file its Opposition to Defendants Aruze
 25 Gaming America, Inc.’s and Kazuo Okada’s Motion to Dismiss Patent Infringement Counts I
 26 Through X (“Motion to Dismiss,” filed on January 6, 2021 – ECF No. 81) is extended for 7 days,
 27 from February 22, 2021 to March 1, 2021. This is the second stipulation for extension of time

1 regarding Plaintiff's Opposition. The Court previously granted the parties' request to extend the
2 standard page and time limitations for briefing on Defendants' Motion to Dismiss. ECF No. 80.
