16 **STIPULATION AND PROPOSED ORDER TO EXTEND DISCOVERY**

17 IT IS HEREBY STIPULATED AND AGREED by and between Plaintiff GAYLE
18 JONES and Defendants MERCER TRANSPORTATION CO. INC., and JAMES
19 BRANDENBURG, by and through their respective counsel of record, that the parties be
20 permitted to extend the discovery period for a period of sixty (60) days. This case has not yet
21 been set for trial

22 **I. INTRODUCTION**

23 This case arises from a motor vehicle accident that occurred on December 20, 2018, in
24 Clark County, Nevada. In her Complaint, filed on November 25, 2019, Plaintiff asserted claims

1 of negligence and negligent entrustment of vehicle against Defendants. Pursuant to the
2 Scheduling Order issued January 17, 2020, the parties had until November 16, 2020 to disclose
3 rebuttal expert witnesses and the last day to complete discovery is December 14, 2020.
4 Dispositive motions and motions in limine must be filed no later than January 13, 2021. In
5 accordance with L.R. 26-3, any stipulation or motion for modification or extension of this
6 discovery plan and scheduling order must be made no later than 21 days before the discovery
7 cut-off date. Therefore, any such stipulations or motions for the close of discovery shall be made
8 not later than Monday, November 23, 2020. The rebuttal expert disclosure deadline has passed.
9 A request made after the expiration of the subject deadline may be granted if the parties
10 demonstrate that the failure to act was the result of excusable neglect.

21 **III. REMAINING DISCOVERY**

22 The parties need to disclose rebuttal experts and conduct the depositions of the parties'

23 expert witnesses. Additionally, depositions are needed of Plaintiff's treating physicians and any

24 other percipient witnesses as disclosed in FRCP 16.1 pre-trial disclosures.

1 The parties anticipate that they may need to conduct other forms of discovery, though not
 2 specified herein, and anticipate doing so on an as needed basis.

3 **IV. REASONS WHY DISCOVERY SHOULD BE EXTENDED**

4 In light of the current COVID-19 precautions the parties require additional time to
 5 disclose rebuttal experts, conduct expert witness depositions, and obtain relevant records. The
 6 parties did not request an extension of the rebuttal expert witness disclosure deadline 21 days
 7 prior to the subject deadline because they expected to meet the deadline as scheduled. However,
 8 due to a last-minute scheduling conflict with Defendants' rebuttal witness beyond the parties'
 9 control, the parties informally agreed on November 16, 2020, to extend the rebuttal expert
 10 witness disclosure deadline and the discovery deadline by sixty days. This unexpected and
 11 unintentional brief continuance constitutes excusable neglect. This request is timely as to the
 12 discovery deadline pursuant to L.R. 26-3. This case is not currently set for trial; therefore, no
 13 other dates will be affected by the extension of these deadlines. As such, good cause exists to
 14 grant the parties' request to extend the rebuttal expert witness disclosure deadline and the
 15 discovery deadline by a period of sixty (60) days, as set forth below.

16 **V. PROPOSED SCHEDULE OF DISCOVERY**

17 The parties request an extension for the remaining discovery deadlines as follows:
