**ORDER GRANTING  
JOINT MOTION TO EXTEND  
DEADLINE TO RESPOND TO  
PLAINTIFF'S COMPLAINT (SIXTH  
REQUEST)**

23 Plaintiff, Glenna M. Duca ("Plaintiff"), and Defendant, Flagstar Bank, FSB. ("Flagstar")  
24 (collectively the "Parties"), by and through their counsel of record, hereby stipulate and agree as  
25 follows:

26 On June 3, 2020, Plaintiff filed the Complaint [ECF No. 1]. Flagstar was served with  
27 Plaintiff's Complaint on June 5, 2020. As such, Flagstar's original deadline to respond to the  
28 Complaint was June 26, 2020. The Court extended that deadline to July 27, 2020 via an Order  
Granting Joint Motion to Extend Deadline to Respond to Plaintiff's Complaint [ECF No. 9]. The  
Court extended that deadline to August 17, 2020 via an Order granting Flagstar's Unopposed  
Motion to Extend Deadline to Respond to Plaintiff's Complaint [ECF No. 11]. The Court again  
extended the deadline to September 8, 2020, via an Order Granting Joint Motion to Extend  
Deadline to Respond to Plaintiff's Complaint [ECF No. 13]. The Court extended the deadline  
for a fourth time to September 29, 2020, via an Order Granting Joint Motion to Extend Deadline  
to Respond to Plaintiff's Complaint [ECF No. 15]. The deadline for Flagstar to respond to  
Plaintiff's complaint was later extended a sixth time to October 13, 2020 [ECF No. 17].

1 The Parties have engaged in settlement discussions but recently determined settlement is  
2 unlikely. The Parties have discussed extending the deadline for Flagstar to respond to Plaintiff's  
3 Complaint by one additional week.

4 WHEREAS, the Parties hereby stipulate and agree to extend the deadline for Flagstar to  
5 file its responsive pleading to Plaintiff's Complaint to October 20, 2020.

6 This is the sixth stipulation for extension of time for Flagstar to file its responsive  
7 pleading. The extension is requested in good faith and is not for purposes of delay or prejudice to  
8 any other party. The parties do not anticipate requesting any further extensions.

9 As part of this stipulation, Flagstar agrees to participate in any Rule 26(f) conference that  
10 occurs during the pendency of this extension.
