(collectively, the "Parties"), by and through their counsel of record, hereby request a thirty (30) day extension to the initial expert disclosure deadline in accordance with Local Rule 26-3 and Local Rule IA 6-1. Counsel for BONY recently learned that its expert is no longer able to author its initial expert report prior to early April 2023 due to upcoming deposition and trial conflicts, as well as a university course he is teaching for the remainder of February through early March 2023. As such, good cause exists to support the request for an extension to the initial expert deadline.

This is the Parties fourth request for an extension of time to the current discovery plan and counsel submits that the request is brought in good faith, supported by good cause in compliance with LR 26-3, and is not intended to cause delay.
