**STIPULATED MOTION FOR
 EXTENSION OF SCHEDULING

(First Request)

26 Plaintiff Lance Mancuso (“Plaintiff”) and Defendants USAA Savings Bank,
 27 Experian Information Solutions, Inc., Equifax Information Services, LLC and Trans
 28 Union LLC (collectively, the “Parties”), stipulate and agree that the Court amend its

1 Scheduling Order, extending all deadlines by 90 days, and would respectfully show the
2 Court as follows:

- 4 1. On November 13, 2020, the Court entered the Discovery Plan and Scheduling
5 Order (Doc. 32).
 - 6 2. To date, parties have exchanged written discovery in this matter. Production of
7 documents is ongoing, and depositions are upcoming.
 - 8 3. In light of the holiday season, and the COVID-19 pandemic, the parties do not
9 anticipate completing adequate fact discovery to provide to expert witnesses on or
10 before January 29, 2021.
 - 11 4. The Parties hereby approach the Court in advance for an amended Scheduling
12 Order to seek additional time.
 - 13 5. The Parties believe February to be a reasonable time during which the fact and lay
14 depositions can take place.

17 Considering the foregoing, the Parties respectfully request that this Court extend
18 the following deadlines by 90 days:

19 **ORDER**

20 IT IS ORDERED that the parties' stipulation is GRANTED in part and DENIED in
21 part. The Court finds that the parties have not established good cause for a 90-day
22 extension. Instead, the deadlines in the operative DPSO will be extended by 60 days.
23 The parties may seek an additional extension if they absolutely cannot complete
24 discovery within this extended period.
