26 ORDER AUTHORIZING DEPOSIT OF
27 FUNDS INTO THE COURT
28 REGISTRY AND SETTING
SCHEDULING CONFERENCE
PURSUANT TO LR 22-1

30 The Court having considered Plaintiff Wells Fargo, N.A.'s Motion for
31 Interpleader Deposit And For The Court to Set A Scheduling Conference as Required
32 by LR 22-1 and for good cause shown:

33 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT** Wells Fargo
34 N.A.'s Motion is **GRANTED**.

35 **IT IS FURTHER ORDERED, ADJUDGED AND DECREED:**

36 1. Wells Fargo, N.A. is granted leave to deposit \$1,200,000 (the
37 "Interpleader Funds") into the Registry Account for this Court;

38 2. The Clerk of the Court shall accept tender of the Interpleader Funds
from Wells Fargo, N.A.;

1 3. Upon receipt of the Interpleader Funds, the Clerk of Court shall deposit
2 the same into the United States Treasury to be invested in the Court Registry
3 Investment System (CRIS) Disputed Ownership Fund (DOF), the investment
4 management tool of the Administrative Office of the United States Courts;

5 4. The Interpleader Funds shall be placed in an interest-bearing account
6 in the name of "Clerk of Court of the United States District Court for the District of
7 Nevada, Civil Action No. 2:21-cv-00346-APG-EJY;"

8 5. Upon deposit of the Interpleader Funds, as may be evidenced by notice
9 from the Clerk or a notice attaching a receipt of deposit filed by Wells Fargo, N.A.,
10 Wells Fargo may lodge an order discharging Wells Fargo from further liability
11 relating to the Interpleader Funds;

12 6. The Administrative Office of the United States Courts shall deduct a fee
13 from interest earnings, not exceeding that authorized by the Judicial Conference of
14 the United States and set by the Director of the Administrative Office, at an annual
15 rate of two-tenths of one percent of all funds deposited under 28 U.S.C. §1335,
16 whenever such income becomes available for deduction in the investment so held and
17 without further order of the Court;

18 7. The Interpleader Funds deposited with the Court Registry Investment
19 System shall remain on deposit until further order of the Court; and

20 8. The Court shall set a scheduling conference as required by LR 22-1.
