**ORDER FOR JUDGMENT DEBTOR
EXAMINATION OF JOSE A. ORTEGA
MEDINA**

It appearing to the Court, by the Petition of Plaintiff, Avocado Oil De Mexico, Inc., in the above-entitled matter, that a Stipulated Judgment was recovered in said action against Defendant, Jose A. Ortega Medina, on September 15, 2021, in the sum of \$71,792.00, plus interest accrued at the rate of 18% annually of \$6,064.55 through June 15, 2021, and accruing thereafter at in the amount of \$35.40 per day, together with attorney's fees and costs in the sum of \$11,582.73, that one payment of \$3,083.33 was made on the Stipulated Judgment and a writ of garnishment was returned for \$102.78 and no payments were made thereafter, Defendant having defaulted under the terms of the Stipulated Judgment, and whereas Federal Rule of Civil Procedure 69 and NRS 21.270 provides for the examination of judgment debtors under such circumstances:

IT IS HEREBY ORDERED that **Jose A. Ortega Medina appear on the 22nd day of March, 2023, at the hour of 10:00 a.m., at the law office of BLACK & WADHAMS, located at 10777 W. Twain Ave., Suite 300, Las Vegas, Nevada 89135,** or through other electronic means, and on such further days as I shall name, to make discovery under oath before a notary public, or some other officer

1 authorized by law to administer oaths, concerning Defendant Jose A. Ortega Medina's property, interests
2 or assets.

3 IT IS FURTHER ORDERED that said Defendant Jose A. Ortega Medina bring to said hearing
4 the documents set forth in Exhibit "A" attached hereto and incorporated herein by this reference.

5 IT IS FURTHER ORDERED that a copy of this Order, together with a copy of the Notice of
6 Judgment Debtor's Exam, be forthwith served on said Defendant Jose A. Ortega Medina or on his
7 attorney or registered agent of the State of Nevada, in the manner provided by law for service of
8 Summons.

9 Failure to appear at the time and place stated above may be punishable for contempt by the Judge.

10 IT IS FURTHER ORDERED that ECF No. 32 is GRANTED.

7. Any and all documents relating to real property including, but not limited to, deeds of trust, mortgages, deeds, leases, contracts, or other papers reflecting an interest in real property held by the Judgment Debtor Medina.
8. Any and all check stubs evidencing receipt of income by Judgment Debtor Medina, from any employer from the period of January 1, 2021 to the present.
9. Any and all documents reflecting or relating to any trusts, wherein the Judgment Debtor Medina is either a beneficiary, trustee, or trustor.
10. Conveyances or transfers of any real or personal property by Judgment Debtor Medina to a trust or any third party from January 1, 2020 to present.

- 1 11. Financial statements of the Judgment Debtor Medina from January 1, 2021 to the present.
- 2 12. Any and all documents including, but not limited to, promissory notes or contracts, which reflect

- 5 24. A list, prepared specifically for the purpose of responding to this Order, identifying the names
6 and addresses of persons who have served as bookkeepers, accountants, or financial advisers for
7 Judgment Debtor Medina from January 1, 2020, to present.

9 to whom Judgment Debtor Medina has paid, given, or conveyed any real or personal property
