**STIPULATION AND ORDER TO

**[FIRST REQUEST]**

11 **B. Joint Pre-Trial Order.**

12 The parties shall submit the Joint Pretrial Order, pursuant to LR 26(1)(e)(5) thirty (30)  
13 days after the date set for filing dispositive motions, on January 24, 2022, unless dispositive  
14 motions are filed, in which case the date for filing the Joint Pretrial Order shall be suspended  
15 until thirty (30) days after the decision on the dispositive motions or further order of this Court.

17 This request for an extension is made in good faith and joined by all the parties in this  
18 case. Trial is not yet set in this matter. Accordingly, this extension will not delay this case.  
19 Moreover, since this request is a joint request, neither party will be prejudiced. The extension
