Relator Peggy Thornton and Defendants Apartment Management Consultants, LLC and Rene Richardson (collectively "AMC"), by and through their respective undersigned counsel, hereby stipulate to extend AMC's deadline to respond to Ms. Thornton's Second Amended Complaint ("SAC") by two weeks, to and including **November 12, 2024**, with the following background and reasons:

- 1. Ms. Thornton filed her SAC on September 24, 2024. ECF No. 108.
- 2. Under FRCP 15, AMC's response to the SAC was therefore due on October 8, 2024.
- 3. The Parties stipulated to grant AMC an additional three weeks to assess the SAC given the multiple rounds of motion-to-dismiss briefing filed thus far and in light of AMC's counsels' conflicting work travel. ECF No. 113.
- 4. This extension also mirrored the one granted to co-defendant TMIF. ECF No. 110.
- 5. AMC now requests an additional two weeks, to and including November 12, 2024, to respond to the SAC given unexpected scheduling conflicts. Specifically, Ms. Dove and Mr. Kahn both serve as pro bono counsel in a First Amendment, Section 1983 suit pending before this District, which was just reassigned to the Honorable Richard F. Boulware, who issued an order several days ago unexpectedly advancing the pre-trial deadlines, including motions in limine, by two weeks, to next week November 1, 2024. *Santopietro v. Howell, et al.*, 2:12-cv-01648-RFB-EJY, ECF No. 110.
- 6. Additionally, Mr. Kahn experienced severe food poisoning last week, greatly limiting his ability to work for several days.
- 7. The Parties agree that this stipulation is entered into in good faith and will not unduly delay proceedings, noting that this Court recently granted the stipulation staying discovery in this matter until any challenges to the SAC are resolved. ECF No. 109.
