ALLISON, Case No. 2:21-cv-01339-RFB-EJY Plaintiff, 4 **ORDER** v. 5 CLARK COUNTY DETENTION CENTER, 6 Defendant. 7 On July 14, 2021, Plaintiff, an inmate in the custody of the Clark County Detention Center 8 9 ("CCDC"), filed what appears to be a proposed complaint thereby initiating a civil action in this Court. ECF No. 1-1. Plaintiff has neither paid the \$402 filing fee for this matter, nor has he filed an 10 application to proceed *in forma pauperis* in this matter. 11 Under 28 U.S.C. § 1915(a)(2) and Local Rule LSR 1-2, an inmate seeking to commence a 12 civil action may apply to proceed in forma pauperis, which allows the inmate to file the civil action 13 without prepaying the full \$402 filing fee. To apply for in forma pauperis status, the inmate must 14 submit all three of the following documents to the Court: 15 (1) a completed **Application to Proceed** in Forma Pauperis for Inmate, on this Court's 16 approved form (including pages 1 through 3 with the inmate's two signatures on page 3), 17 (2) a Financial Certificate properly signed by both the inmate and a prison or jail official 18 19 (page 4 of this Court's approved form), and (3) a copy of the inmate's prison or jail trust fund account statement for the previous 20 six-month period. If Plaintiff has not been at the facility a full six-month period, Plaintiff 21 must still submit an inmate account statement for the dates he has been present at the facility. 22 The Court grants Plaintiff a one-time extension to file a fully complete application to 23 proceed in forma pauperis containing all three of the required documents, or in the alternative, pay 24 the full \$402 filing fee for this action on or before September 14, 2021. Absent unusual 25 circumstances, the Court will **not** grant any further extensions of time. If Plaintiff is unable to file a 26

fully complete application to proceed in forma pauperis with all three required documents or pay

the full \$402 filing fee on or before **September 14, 2021**, the Court will recommend dismissal of this case **without prejudice** allowing Plaintiff to file a new case with the Court when Plaintiff is able to acquire all three of the documents needed to file a fully complete application to proceed *in forma pauperis* or pay the full \$402 filing fee.

A dismissal **without prejudice** means Plaintiff does not give up the right to refile the case with the Court, under a new case number, when Plaintiff has all three documents needed to submit with an application to proceed *in forma pauperis*. Alternatively, Plaintiff may choose not to file an application to proceed *in forma pauperis* and instead pay the full filing fee of \$402 on or before **September 14, 2021** to proceed with this case.

The Court will retain Plaintiff's compliant (ECF No. 1-1), but the Court will not file the complaint unless and until Plaintiff timely files a fully complete application to proceed *in forma* pauperis with all three documents or pays the full \$402 filing fee.

Accordingly, and for the foregoing reasons, IT IS HEREBY ORDERED that the Clerk of the Court shall send Plaintiff the approved form application to proceed *in forma pauperis* by an inmate, as well as the document entitled information and instructions for filing an *in forma pauperis* application.

IT IS FURTHER ORDERED that on or before **September 14, 2021**, Plaintiff shall either pay the full \$402 filing fee for a civil action (which includes the \$350 filing fee and the \$52 administrative fee) or file with the Court:

- (1) a completed <u>Application to Proceed in Forma Pauperis for Inmate</u> on this Court's approved form (including pages 1 through 3 of the form with the inmate's two signatures on page 3),
- (2) a <u>Financial Certificate</u> properly signed by both the inmate and a prison or jail official (page 4 of this Court's approved form), and
- (3) a copy of the <u>inmate's prison or jail trust fund account statement for the previous</u> <u>six-month period</u>. If Plaintiff has not been at the facility a full six-month period, Plaintiff must still submit an inmate account statement for the dates he has been present at the facility.

IT IS FURTHER ORDERED that, if Plaintiff does not file a fully complete application to proceed *in forma pauperis* with all three documents or pay the full \$402 filing fee for a civil action on or before **September 14, 2021**, the Court will recommend dismissal of this action **without prejudice** for Plaintiff to refile the case with the Court, under a new case number, when Plaintiff is able to file a complaint and has all three documents needed to file a complete application to proceed *in forma pauperis* or pays the full \$402 filing fee.

IT IS FURTHER ORDERED that the Clerk of the Court shall retain Plaintiff's proposed complaint (ECF No. 1-1) but will not file it at this time.
