**STIPULATION AND ORDER TO
EXTEND DEADLINE FOR DEFENDANT
GOLDEN GAMING, LLC TO FILE A
RESPONSE TO PLAINTIFF'S FIRST
AMENDED COMPLAINT [ECF No. 15]**

18 Defendant Golden Gaming, LLC (“Defendant,”) by and through its counsel, Jackson Lewis
19 P.C., and Plaintiff Akneeko A. Carnes (“Plaintiff,”) by and through her counsel, Lagomarsino
20 Law, hereby stipulate and agree to extend the time for Defendant to file a response to Plaintiff’s
21 First Amended Complaint [ECF No. 15]. Defendant was served on October 26, 2021 with a copy
22 of the First Amended Complaint [ECF No. 15]. Defendant’s response to the First Amended
23 Complaint [ECF No. 15] is currently November 16, 2021.

Plaintiff and Defendant have agreed to a three-week extension of time for Defendant to file a response to the First Amended Complaint [ECF No. 15]. Defendant shall, therefore, have an extension of time to respond to the First Amended Complaint [ECF No. 15] as follows:

27 1. Defendant's response to the First Amended Complaint [ECF No. 15] is currently

1 2. Plaintiff has announced her intent to file a second amended complaint, which
2 would render Defendant's response to the First Amended Complaint [ECF No. 15] unnecessary.

3 3. Defendants shall have until December 7, 2021 to file a response to the First
4 Amended Complaint [ECF No. 15].

5 4. This is the first request for an extension of time for Defendant to file a response to
6 Plaintiff's First Amended Complaint [ECF No. 15].

7 5. This request is made in good faith and not for the purpose of delay.

8 6. Nothing in this Stipulation, nor the fact of entering to the same, shall have the
9 effect of or be construed as waiving any claim or defense held by any party hereto.
