20 **I. DISCOVERY COMPLETED**

24 **III. REASONS THE PARTIES ARE REQUESTING A TRIAL CONTINUANCE**

25 The parties completed discovery, and the trial was set to commence on February 27, 2023.  
26 Following this trial setting, the parties discussed and agreed to attend mediation. Before the  
27 mediation was scheduled, on December 23, 2022, an order was issued referring this matter to

4 believe that the matter may resolve with the assistance of the magistrate judge.

5 **IV. PROPOSED SCHEDULE FOR REAMINING DISCOVERY**

6 The parties request that this matter be set for trial no sooner than 45 days after March 9,  
7 2023, so that the parties will have adequate time to prepare for trial should resolution not be reached  
8 during the settlement conference.
