(SECOND REQUEST)

NewRez LLC dba Shellpoint Mortgage Servicing and SFR Investments Pool 1, LLC, hereby stipulate and agree that Shellpoint shall have an additional seven (7) days, up to and including **December 2, 2022**, to file its response to SFR's first amended complaint, which is currently due November 25, 2022. 
