**STIPULATION AND ORDER TO
EXTEND DEADLINE TO RESPOND TO
FIRST AMENDED COMPLAINT (ECF
NO. 60)**

(SECOND REQUEST)

1 NewRez LLC dba Shellpoint Mortgage Servicing and SFR Investments Pool 1, LLC, hereby
 2 stipulate and agree that Shellpoint shall have an additional seven (7) days, up to and including
 3 **December 2, 2022**, to file its response to SFR's first amended complaint, which is currently due
 4 November 25, 2022. SFR's first amended complaint was filed on October 12, 2022 [ECF No. 60].

5 Good cause exists to grant the requested extension. The parties previously stipulated to a
 6 thirty day extension, with the deadline falling on November 25, 2022. Shellpoint's counsel did not
 7 take into account the holiday on November 24, 2022. The offices of Shellpoint's counsel will be
 8 closed on November 24 and November 25. Additionally, Shellpoint's counsel will be out on leave
 9 preceding the holiday office closure. This is the parties' second request for an extension of these
 10 deadlines and is not intended to cause any delay or prejudice to any party.
