 causes of action for breach of contract, contractual breach of implied covenant of good faith and fair
 dealing and tortious breach of implied covenant of good faith and fair dealing. Additionally,
 Defendants Langin and Zebarth filed motions to dismiss Plaintiff's cause of action for negligent
 misrepresentation.

16 4. The deadline to file Plaintiff's Oppositions to Defendants' Motions to Dismiss is
17 August 1, 2022.

18 5. Plaintiff's counsel did not receive notice of the above-mentioned motions to dismiss
19 until July 21, 2022, through no fault of the Court, which does not provide sufficient time to prepare
