29 Defendant Experian Information Solutions, Inc. (“Experian”) and Plaintiff Rastelli
30 Regalado (“Plaintiff”), by and through their respective counsel of record, hereby submit this
31 stipulation to extend the time for Experian to respond to Plaintiff’s Complaint (ECF No. 1)
32 pursuant to LR IA 6-1.

33 Plaintiff filed his Complaint on August 16, 2022, and currently Experian’s responsive
34 pleading is due September 20, 2022. (ECF No. 1.) The first extension will allow Experian an
35 opportunity to investigate the facts of this case and to avoid the incurrence of additional
36 attorneys’ fees when this matter may be resolved shortly, Plaintiff and Experian stipulate and
37 agree that Experian shall have an extension until October 11, 2022, to file its responsive pleading.

1 This is Experian's first request for an extension of time to respond to the Complaint and is
2 not intended to cause any delay or prejudice any party, but to permit both Plaintiff and Experian
3 an opportunity to more fully investigate the claims alleged.
