22 stipulation to extend the time for Experian to respond to Plaintiff's Complaint (ECF No. 1)

24 Plaintiff filed his Complaint on August 16, 2022, and currently Experian's responsive
25 pleading is due September 20, 2022. (ECF No. 1.) The first extension will allow Experian an
26 opportunity to investigate the facts of this case and to avoid the incurrence of additional

28 agree that Experian shall have an extension until October 11, 2022, to file its responsive pleading.

3 an opportunity to more fully investigate the claims alleged.
