**STIPULATION AND ORDER TO
 EXTEND DEADLINE TO FILE
 DISMISSAL AS TO DEFENDANT
 EQUIFAX INFORMATION SERVICES,
 LLC**

24 Plaintiff Rastelli Regalado (“Plaintiff”) and Defendant Equifax Information Services,
 25 LLC (“Equifax”) (collectively, the “Parties”) hereby stipulate to and request additional time for
 26 the dismissal of Plaintiff’s claims against Equifax.

27 Plaintiff’s claims against Equifax were set to be dismissed with prejudice on February

1 5, 2024, pursuant to the Notice of Settlement dated December 6, 2023 (Doc. 86) and the Court's
2 Order (Doc. 87). The Parties have diligently documented their settlement and will be able to
3 fully perform the settlement terms (including a stipulated dismissal of Equifax) within thirty
4 (30) days after the current February 5, 2024, deadline.

6 Therefore, the Parties stipulate and request that the Court extend the deadline to file a
7 Stipulation of Dismissal with Prejudice as to Defendant Equifax Information Services, LLC to
8 **March 6, 2024.**
