**STIPULATION AND ORDER FOR

Plaintiff, the Board of Trustees of Southern Nevada Culinary and Bartenders Pension Trust (“Plaintiff”), and the Defendants, SEA Vegas Incorporated, a Nevada corporation, Nabon Thai Market, Inc., a New York corporation, Spice Corner 236, Inc., a New York corporation, Tong Thai Connecticut LLC, a Connecticut limited liability company, Kitlen Management, Inc., a New York corporation, KL 747, Inc., a New York corporation, Kitlen Realty, LLC, a New York limited liability company, Kittigron Lirtparanuk, an individual, and Yongyut Limleartvate, an individual (collectively referred to herein as “Defendants”) (Plaintiff and Defendants are collectively referred to herein as the “Parties”), each acting by and through their undersigned counsel, hereby Stipulate and Agree pursuant to Fed. 2. The Settlement Agreement resolves all claims asserted in this case and requires certain actions to be performed on or before April 15, 2025.

3. All claims asserted herein shall be and are hereby dismissed without prejudice.

4. Each of the Parties shall bear its own attorney's fees and costs, except as expressly agreed between the Parties in the Settlement Agreement.

5. The Court shall retain jurisdiction to enforce the terms of the Settlement Agreement.
