**STIPULATION AND ORDER TO
 EXTEND DISCOVERY DEADLINES
 (FIRST REQUEST)**

 20 PURSUANT TO LR 6-1 and LR 26-4, PLAINTIFFS, by and through their undersigned
 21 counsel of record, and Defendants CLARK COUNTY SCHOOL DISTRICT (CCSD) and
 22 NICOLE RILEY (Riley), by and through their undersigned counsel of record, hereby stipulate and
 23 request that this Court extend discovery deadlines in the above-captioned case by ninety days as
 24 outlined herein. This is the parties' **First Request** to extend the time to complete discovery.

25 In support of this Stipulation and Request, the parties state as follows:

26 I. Procedural Posture of the Case:

- 27 1. On May 1, 2023, Plaintiffs filed the subject Complaint. (ECF No. 1)
 28 2. On May 30, 2023, Defendant CCSD filed its Answer to Plaintiffs' Complaint. (ECF

- 2 3. On June 27, 2023, Defendant Riley filed her Answer to Plaintiffs' Complaint. (ECF
- 3 No. 9)
- 4 4. On July 18, 2023, the Court approved the parties proposed Joint Discovery Plan and
- 5 Scheduling Order. (ECF No. 11)
- 6 5. On September 5, 2023, the parties submitted to the Court a proposed Stipulated
- 7 Protective and Confidentiality Order (ECF No. 13)

8 **II. Discovery Completed to Date**

- 9 1. Initial Disclosures were served:
- 10 a. By Defendants CCSD and Riley on July 21, 2023
- 11 b. By Plaintiffs on July 24, 2023
- 12 2. Interrogatories and Requests for Production of Documents were served to Plaintiffs
- 13 by Defendant CCSD on August 24, 2023; Plaintiffs' Responses thereto are due on
- 14 September 26, 2023.
- 15 3. Deposition of CCSD witness Eva Silvas is scheduled for September 7, 2023.
- 16 4. Deposition of CCSD witness Traci Mitchell is scheduled for September 7, 2023.
- 17 5. Deposition of CCSD Defendant Nicole Riley is scheduled for September 26, 2023.

18 **III. Discovery Remaining**

- 19 1. In-classroom observation of the minor Plaintiff by Plaintiffs' expert, scheduling of
- 20 which has been complicated by first of the year administrative staffing changes at the
- 21 minor Plaintiff's current school.
- 22 2. Disclosure of Plaintiffs' Computation of Damages
- 23 3. Determination of the scope, need for, and scheduling of a FRCP Rule 35 examination
- 24 of the minor Plaintiff, contingent upon disclosure of Plaintiffs' Computation of
- 25 Damages.
- 26 4. In addition to deposition of the named Defendant, depositions of an estimated six
- 27 additional CCSD witnesses to events pertinent to the facts and circumstances
- 28 surrounding the allegations of the Complaint.

- 1 5. Depositions of any and all physical and mental healthcare providers for the minor
- 2 Plaintiff, the number of which is currently unknown.
- 3 6. Depositions of the minor Plaintiff's parents and guardians.
- 4 7. Upon Plaintiffs' production of Authorizations for physical and mental health care
- 5 records, and for childcare records, Subpoenas Duces Tecum will be issued to gather
- 6 evidence of the minor Plaintiff's treatment and interaction at locations other than
- 7 CCSD.
- 8 8. The parties will produce expert reports and rebuttal experts.
- 9 9. The parties will depose experts as disclosed.

10 IV. Why Remaining Discovery Has Not Been Completed

11 On September 5, 2023, the parties submitted a proposed Stipulated Protective and
12 Confidentiality Order to the Court. (ECF No. 13.) This matter involves students with
13 educational needs which are subject to individualized educational plans protected by the Federal
14 Educational Rights and Privacy Act. The proposed Protective and Confidentiality Order is
15 intended to allow for restricted disclosure of relevant student information as relevant and
16 proportional to the needs of this case and solely for the purpose of evidencing facts at issue in
17 this litigation. Once the Protective Order is in place, records in the possession of CCSD can be
18 more fully disclosed.

19 The parties have been actively attempting to coordinate schedules of the parties'
20 attorneys and of multiple CCSD witnesses at the commencement of the school year. Due to the
21 attorneys' calendars and conflicting discovery deadlines in other cases, the depositions and
22 supplemental disclosures necessary to the parties' completion of discovery, have not been
23 accomplished in spite of the parties' good faith efforts.

24 Plaintiffs have not yet disclosed a computation of damages nor any treatment records for
25 the minor Plaintiff concerning the injuries and/or damages claimed to have been suffered by
26 Defendants' conduct. Absent that disclosure Defendants have been unable to determine the need
27 for or a proposed scope of a Rule 35 examination of the minor Plaintiff.

1 Finally, Plaintiffs’ expert has requested an in-classroom observation of the minor
 2 Plaintiff which has not yet been coordinated between the parties due to first of the school year
 3 administrative staffing changes at the minor Plaintiff’s current school.

4 Accordingly, the parties request a 90-day extension of the discovery deadlines as set forth
 5 below.

6 V. Requested Extension or Modification of the Discovery Plan and Scheduling Order

7 LR 26-4 governs modifications or extension of the discovery plan and scheduling order.
 8 LR 26-3 requires that any stipulation or motion must be made not later than twenty-one (21) days
 9 before the expiration of the subject deadline and comply fully with LR 26-4.

10 The current discovery deadlines and the parties’ proposed extended deadlines are:
