**STIPULATION AND ORDER TO

(Second Request)

18 **STIPULATION**

19 Pursuant to Local Rules IA 6-1, IA 6-2, and LR 7-1, Defendant Britney Gaitan and Plaintiff
20 Wayan Garvey (“Plaintiff”) hereby stipulated and agreed as follows:

- 21 1. Plaintiff commenced this action on June 12, 2023. ECF No. 1.
- 22 2. On September 14, 2023, Plaintiff filed an amended complaint. ECF No. 25
- 23 3. On September 19, 2023, Ms. Gaitan moved to dismiss Plaintiff’s amended
24 complaint. ECF No. 28.
- 25 4. On April 26, 2024, the Court denied Ms. Gaitan’s motion to dismiss the amended
26 complaint. ECF No. 49.
- 27 5. On May 10, 2024, the parties submitted a stipulation to extend the time for Ms.
28 Gaitan to answer the amended complaint to May 31, 2024 [ECF No. 51], which was granted on

1 May 14, 2024 [ECF No. 52].

2 6. Due to unforeseen scheduling conflicts and travel of Ms. Gaitan's counsel, the
3 parties agree that Ms. Gaitan shall have up to and including June 14, 2024, to answer the amended
4 complaint.

5 7. This is the second time Ms. Gaitan has requested an extension to respond to
6 Plaintiff's amended complaint. Ms. Gaitan was granted two prior extensions to respond to
7 Plaintiff's original complaint prior to Plaintiff filing his amended complaint. ECF No. 18; ECF
8 No. 12.

9 8. The requested extension is not intended to cause any delay or to prejudice any party.
