28 **STIPULATION AND ORDER TO
CONTINUE STAY PENDING
MEDIATION**

29 [ECF No. 10]

30 Plaintiff Victor Aguirre-Villanueva (“Plaintiff”) and Defendant HMB LLC d/b/a and a/k/a
31 Servehzah Bottle Shop and Tap Room (“Defendant”) (collectively, the “Parties”) by and through
32 their respective counsel, hereby stipulate and respectfully request that the Court extend the stay
33 pending completion of the parties’ mediation on December 14, 2023.

34 In support of this request, the Parties provide the following information for the Court’s
35 consideration:

1 1. On May 30, 2023, Plaintiff filed his Collective and Class Action Complaint with the
2 Eighth Judicial District Court in and for Clark County, Nevada. *See* ECF No. 1-1. Thereafter, on
3 June 29, 2023, Defendant removed the action to this Court. *See* ECF No. 1. Defendant filed its
4 Answer (ECF No. 5) on June 30, 2023.

5 2. Upon the Parties' stipulation, on August 14, 2023, the Court entered an Order to
6 Stay Discovery Pending Mediation, which stayed these proceedings for approximately 90 days
7 (until November 13, 2023) in order for the parties to select an available mediator and complete an
8 agreed-upon mediation. *See* ECF No. 8.

9 3. While the parties have selected a mediator, the Parties have not yet completed
10 mediation. Mediation is scheduled for December 14, 2023 before the Honorable Elizabeth
11 Gonzalez, Retired with Advanced Resolution Management.

12 4. The Parties are currently devoting their attention to the mediation and are hopeful
13 they will reach a resolution that will avoid protracted litigation. In order to conserve the Parties'
14 and the Court's resources, to promote judicial economy, and to increase the likelihood of a
15 successful mediation, the Parties have agreed, subject to the Court's approval, to extend the current
16 stay until December 14, 2023, in order for the parties to complete the mediation.

17 5. In the event that the parties are unable to reach a resolution at the mediation, the
18 parties agree to file a joint status report informing the Court of the same. The parties further agree
19 to file a proposed discovery plan and scheduling order within two weeks of filing the joint status
20 report.
