21 IT IS HEREBY STIPULATED AND AGREED by the parties' counsel of  
 22 record that the Court's Order Scheduling Settlement Conference (ECF No. 24) be  
 23 vacated as the parties agree they have exhausted all settlement discussions at this point.

24 The matter before the Court is a Petition to Vacate an Arbitration Award (ECF  
 25 No. 1). After the Arbitrator issued his Award, the parties engaged in significant  
 26 settlement discussions in an attempt to resolve the matter prior to Plaintiff filing its

3 The parties, therefore, respectfully request that the Court vacate the settlement  
4 conference scheduled for August 2, 2024, and the pre-settlement conference call  
5 scheduled for August 1, 2024. The parties will continue to comply with the Court's  
6 Special Scheduling Order (ECF No. 19).
